- <u>TWO SHOWS</u>: <u>Dressage</u>, <u>By Chance 1</u> (July 25) and <u>Dressage</u>, <u>By Chance 2</u> (July 26) are **two SEPARATE shows** over the same weekend. Each show must be **entered as a separate show**. If an entry is mailed, send separate documents and separate checks.
- **CLOSING DATE:** The closing date is Midnight, July 11, 2020. The show is limited to two arenas. If the arenas fill before the closing date, the show will close early.
- **<u>REQUIRED ENTRY DOCUMENTS</u>**: This show requests that <u>all</u> documents be submitted with the entry, as follows:
  - 1. Entry Form: Completed Entry Form.
  - 2. Payment: Full payment (online or check made out to By Chance Farm).
  - 3. USDF/USEF Release Form: with all signatures (no same).
  - **4.** Copy of current Coggins (within 12 months of the show date). Must have horse name the same as on show entry and USEF/USDF recording/registration.
  - **5. Proof of Rider/Owner/Trainer USEF/USDF memberships**, unless exempt (use <a href="https://www.EqVerification.org">www.EqVerification.org</a>), or pay USDF and USEF Non-Member Fees
  - **6. Proof of Rider/Owner/Trainer Safe Sport Training**. Applies to USEF members age 18 and over. The proof is on the USEF membership verification. If not on the verification, submit certificate of training.
  - 7. Proof of horse USEF recording (USEF Lifetime, Annual, USEF HID, or USDF HID) and USDF registration (USDF Lifetime or USDF HID), unless exempt (use <a href="https://www.EqVerification.org">www.EqVerification.org</a>).
  - **8. Proof of current vaccination** IAW USEF GR845. Must have horse name the same as on show entry and USEF/USDF recording/registration.
- <u>STALLS</u>: There will be 24 stalls available on a first-come first-served basis. Priority will be given to stall requests for the entire weekend. If you enter both shows, please pay for the stall with the first show's entry. <u>More details in paragraph 14.</u>

#### 7. ENTRY PROCEDURES

As a courtesy, show secretaries usually enter riders in their shows wo all the required documentation; however, this can
create major issues at show check-in, particularly (1) the chance a rider may not be allowed to ride due to insufficient
documents and (2) the additional time it takes to sign-in at the show office due to missing paperwork that can be
submitted before the show. This show goes to every effort to get all documentation <u>before</u> the show so we can all have a
good show experience.

#### ENTRY SUBMISSION:

- Entrants may submit entries by one of three methods:
  - (1) COMPLETELY ONLINE VIA EQUESTRIAN ENTRIES: Preferred method. See <a href="www.EquestrianEntries.com">www.EquestrianEntries.com</a>. With this online system, riders and owners agree that they have read the OFFICIAL PRIZE LIST and agree to follow all the class specifications, requirements and conditions therein.
  - (2) PARTIALLY ONLINE VIA EQUESTRIAN ENTRIES: Complete the entry form in EE, print, then snail mail as below.
  - (3) COMPLETE THE FORM BY HAND THEN SNAIL MAIL WITH OTHER DOCUMENTS: Print the form at the end of this prize list, complete it by hand (PLEASE PRINT VERY VERY VERY CLEARLY!) and snail mail with other required documents (see below). Mail to the Show Secretary, not to By Chance Farm.

  - (6) Proof of Rider/Owner/Trainer Safe Sport Training. Applies to USEF members age 18 and over. The proof is on the USEF membership verification. If not on the verification, submit certificate of training.
  - (7) Proof of horse USDF Registration and USEF Recordation (horses only participating in Introductory and/or Opportunity classes are exempt). <a href="https://www.eqverification.org">www.eqverification.org</a>.
  - (8) Proof of vaccination as in USEF GR845 (horse name must = entry name = USEF registered name) (https://www.usef.org/forms-pubs/ANcxoLX1gNs/equine-vaccination-rule-gr845).
  - (9) Other Documents: Any other required documentation.
- Required documents (5) and (6) are best submitted via Equestrian Entries or the printed report from <u>www.eqverification.org</u>. Copies of USEF and USDF membership cards and horse USEF Recording and USDF registration documents are accepted.
- o If required documents (3), (4), (5), (6), (7) and (8) are not submitted via EqE, they may NOT be submitted via FAX. They may be submitted via snail mail (do not use a signature required service) sent to the Show Secretary or as an email attachment sent to <a href="LeslieRaulin@gmail.com">LeslieRaulin@gmail.com</a> (the email SUBJECT line must be VERY VERY clear that the email is related to the show or it may not be opened).
- **FULL SHOW**: Entries may be limited if numbers exceed capacity of the facility. The show may fill prior to the closing date. Entries received after the show is full will be placed on a waiting list and the entrant will be notified.
- LATE ENTRIES: Late entries (received by the show secretary after midnight of the closing date) will be accepted on a space available basis. Must include the \$50 late fee.
- SHOW AND ENTRY CHANGES: Show management reserves the right to refuse entries, make changes, deletions, or corrections as deemed necessary.
- **COGGINS**: Negative Coggins valid through the show date is required to enter the show grounds for all horses.
- **PROOF OF VACCINATION**: Documentation valid through the show date is required to enter the show grounds for all horses.
- CORRESPONDENCE:
  - All entries correspondence will be via email or snail mail. No text, telephone or FAX correspondence.
  - o Do not send any entry documentation via registered mail, certified mail, or signature required mail.
- CHECKS: Make checks payable to By Chance Farm, LLC.
- **REFUNDS**. Entry scratches received <u>BEFORE</u> midnight of the original published closing date or the actual closing date/time, whichever is earlier, will be refunded less the office fee. Overpayments greater than \$50 will be refunded, less a \$50 refund fee, if verified BEFORE this closing date. There will be <u>NO REFUNDS</u>, for any reason, <u>AFTER THIS CLOSING</u> DATE, including show cancellation due to Acts of God, acts of terrorism, inclement weather, and/or other emergencies.

#### **8. GENERAL INFORMATION**

- Every class offered herein that is covered by the rules and specifications of the current USEF Rule Book (<a href="https://www.usef.org/compete/resources-forms/rules-regulations/rulebook">https://www.usef.org/compete/resources-forms/rules-regulations/rulebook</a>) will be conducted and judged in accordance therewith.
- USEF rules are in force from the moment the show management allows access to the show grounds. This includes conduct, correct saddlery and equipment, and attire. Riders in classes and tests at all levels in Level 2 Competitions [this competition], ..., may compete wearing breeches and shirts of any color as permitted in DR120.8. Jackets or vests of any type are allowed but not required and neckwear may be worn only if the rider chooses to compete in a riding jacket. Boots and protective headgear are required as specified in DR120.1-6.
- Management reserves the right to split, combine, delete, or add classes dependent on entries. Management also reserves the right to add or substitute judges or make any changes required by circumstances.
- All "no shows" that have not contacted the show office will be considered a scratch for the remainder of the show and time slots may be filled. Riders and owners enter with this understanding and agreement.
- Dogs must be on leashes or crated at all times while on the show grounds.
- Current editions of all tests and score sheets, as posted on the USDF, USEF, and FEI web sites, will be used.
- This is a one-day two-arena show. To ensure participation by many riders and to facilitate show scheduling, each rider is limited to no more than three horses and six rides.

#### 9. USEF HEADGEAR RULE

6. From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds, including non-competing riders, riders on non-competing horses, mounted participants in exhibition classes and those competing in all classes and tests, including Para-Equestrian tests, must wear protective headgear as defined by this rule and otherwise in compliance with GR801. Any rider violating this rule at any time must immediately be prohibited from further riding until such headgear is properly in place. Protective headgear is defined as a riding helmet which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. The harness must be secured and properly fitted. Unless jackets are waived, while in the competition ring, exhibitors wearing protective headgear must wear a short, dark jacket, dark tailcoat (only permitted for tests above Fourth Level), or Armed Services or police uniform (if eligible), dark hatcovers (where applicable) and must otherwise conform to DR120 (see GR801).

#### **10. RIBBONS AND AWARDS**

- Ribbons for first through sixth place. Prize for each first place.
- High Score ribbons for each division (Professional, Adult Amateur and Junior/Young Rider).
- \$100 Prize Money to the High Score AA.
- High Score ribbons for each level (Introductory, Training, First, Second, Third, Fourth, PSG, and FEI (Int & GP).
- Thoroughbred Incentive Program (TIP) Awards (see page 18).

#### 11. ENTRY STATUS AND RIDE TIMES NOTIFICATION

- Acknowledgement of entry receipt and its status will be emailed to each rider. The email subject will be FVD
  Confirmation Mail. Please ensure you include a valid email address with your entry. When the acknowledgement is
  received, the rider is responsible for finding errors and notifying the Show Secretary immediately.
- Ride times will be posted at least four days before the show on the By Chance Farm web site at <a href="http://www.bychancefarm.com/dressage-by-chance">http://www.bychancefarm.com/dressage-by-chance</a> and will be emailed to participants.
- IAW DR126, "The time schedule must be posted in a conspicuous place by noon the day before the competition." The time schedule will be posted at the show office.

#### 12. BRIDLE NUMBERS

All horses, including non-competing horses, must wear their bridle number any time they are off the horse trailer or out of their stall.

#### **13. NON-COMPETING HORSES**

Non-competing horses must accompany a competing horse. For a non-competing horse, enter the show in the usual manner but do not enter any classes. The only fees are the non-compete horse fee of \$10 plus the \$30 office fee and \$30 grounds fee or stabling fee(s). Riders (if applicable), owners and trainers must have USEF / USDF memberships required by the show status of the accompanied competing horse. The USEF D&M horse fee is not paid for non-competing horses but the horse could be tested.

#### **14. STABLING AND WATER**

- 24 temporary 10' x 10' horse stalls with doors will be available. Priority will go to horses entered in both shows. Tack stalls may be requested but may not be available.
- The stalls will be on grass and will be inside a fenced area.
- See the OTHER FEES section for the stall package types and fees.
- If an entry with a stall is scratched, the rider must coordinate with the show secretary re status of the stall. If such coordination is not done, the stall will be relinquished.
- Due to the limited number of stalls, priority will be given to entries requesting a horse stall for the entire weekend (Stall Package HFrSaSu). For these entries, horse stalls will be assigned on a first come first served basis.
- Security and night watch will not be available.
- Groups must complete the Stall Group box (using the same term) on Equestrian Entries or the entry form if they want to be stabled together.
- One bag of bedding is included with stall packages HFrSaSu, HFrSa5 and HSa6Su. Bedding will be available on-site for purchase at \$10/bag.
- The stall area will have one sharps container. Competition management may fine any individual, including trainers, owners, exhibitors or their agents, up to \$100 for improper disposal of needles or other sharp disposable instruments.
- Water will be available for horses.

#### 15. PONIES

If ponies are entered and need a measurement card, an appointment for measuring must be made with show management at least two weeks prior to the show. The owner will be responsible for all costs associated with performing the measurement.

#### **16. COGGINS AND PROOF OF VACCINATION**

- Coggins: IAW Maryland Department of Agriculture, Subtitle 11 Animal Health, Chapter 12 Equine Infectious Anemia, .03 Test Requirements, B. For Exhibition (<a href="https://asci.uvm.edu/equine/law/eia/md\_eia.htm">https://asci.uvm.edu/equine/law/eia/md\_eia.htm</a>), a copy of the horse's negative Coggins report tested within 12 months from the date of the show must be provided. For this show it must be provided to the secretary before the show. A horse not in compliance with this rule is not allowed on the show grounds.
- Vaccination: IAW USEF GR845 (<a href="https://www.usef.org/documents/drugsMeds/2016/2016GR08845VaccineRule.pdf">https://www.usef.org/documents/drugsMeds/2016/2016GR08845VaccineRule.pdf</a>), proof of vaccination for Equine Influenza Virus and Equine Herpes Virus within six months of the date of the show must be provided. For this show it must be provided to the secretary before the show. A horse not in compliance with this rule is not allowed on the show grounds. If the horse falls under USEF GR845.4., all steps in the paragraph must be complied with and proof provided to the show secretary before and during the show.

#### 17. WARM-UP AND COMPETITION ARENAS

Warm-up Arena: One 25m x 58m indoor arena with sand and fiber footing.

Lunging Area: Grass pasture.

**Competition Arenas**: Two 20m x 60m outdoor arenas with sand footing.







#### **20. DIRECTIONS AND MAPS**

- From the Washington Beltway: Take I-270 North for 25.8 miles. Take the MD-109 exit, exit 22, toward Hyattsville/Barnestown, travel 0.2 mi. Keep to the left to take the ramp toward Hyattstown, travel 0.03 mi. Turn left onto Frederick Road / MD-355, travel 0.6 mi. Take first right onto MD-75 / Green Valley Road, travel 4.8 mi. Turn left onto Fingerboard Road / MD-75 / MD-80, travel 0.1 mi. Take the first right onto Green Valley Road / MD-75, travel 2.3 mi. Turn right onto Green Valley Road / MD-75 / MD-877, travel 0.5 mi. Turn left onto Green Valley Road / MD-75, travel 7.8 mi. Turn right onto Liberty Road / MD-26, travel 1.8 mi. Turn left onto Bessie Clemson Road, travel 0.6 mi. By Chance Farm is on the right.
- From the Baltimore Beltway: Take I-70 west for 18.7 miles. Take the MD-94 exit, exit 73, toward Woodbine/Lisbon, travel 0.4 mi. Keep right to take the ramp toward Woodbine, travel 0.05 mi. Merge onto Woodbine Road, travel 7.4 mi. Turn left onto W Liberty Road / MD-26, travel 8.6 mi. Turn right onto Bessie Clemson Road, travel 0.6 mi. By Chance Farm is on the right.

- Do not enter Bessie Clemson Road from Route 31 / New Windsor Road as the turn into show parking is too sharp.

#### 21. RIDER ATTIRE FOR THE SHOW

- See USEF DR120 Dress for dressage riding attire requirements for a level 2 dressage show.
- **USEF DR120.8:** In locations with high average heat and humidity on the date of a competition, management can publish in their prize list that jackets will be waived for the duration of the competition. Alternatively, management can announce prior to or during a competition that competitors can show without jackets when extreme heat and/or humidity is forecast. This waiver applies to all classes including FEI classes at National Competitions. However, competitors must wear protective headgear and a shirt with sleeves and collar, without neckwear, and without decoration except as described under .15 below. T-shirts are not permitted. Members of the Armed Services or police units may wear summer uniforms.
- ACCORDINGLY, JACKETS WILL BE WAIVED FOR THE ENTIRE COMPETITION.

#### 22. HORSE ATTIRE FOR THE SHOW

- See DR121 Saddlery and Equipment for complete requirements.
- DR121.1. [Saddle Pad Logos] ...While in the competition ring ..., a logo/monogram or name may appear on either or both sides of a saddle cloth in an area not exceeding 200 cm2 (26.632 sq. inches). Only the following logos or names are permitted: breed logos (for horses registered with that breed); a national flag (for citizens of that country); USEF or USDF names/logos. Professionals of any age may have a business or product name/logo of their official sponsor. Amateurs may not have a business or product name/logo unless they own the business. Competition award pads and stable name pads are permitted. No other advertisement or publicity is permitted on saddle cloths or horses.
- **DR121.7. Fly hoods** (ear covers) are permitted for all classes in order to protect horses from insects. The fly hoods should be discreet in color and design and should not cover the horse's eyes. Fly hoods may not be attached to the noseband. After completion of the test, the rider or his representative is responsible for removing the fly hood to present to the designated ring steward for inspection to ensure that nothing prohibited has been added (for example, ear plugs). Blinkers and fly masks that cover the horse's eyes are permitted in warmup but are forbidden in the com-petition arena.



#### GR1301.7 – Motor Vehicle Statement:

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

#### USEF Membership Statement:

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR222) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

#### • USEF Rules and Regulations:

## EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.

All questions not covered in these rules and regulations shall be decided by the show management whose decision shall be final.

Every horse entered for competition will comply with the rules of the horse show management, but management will, in no case, be responsible for any loss or damage that may occur, and it shall be condition of entry that each exhibitor shall hold this horse show and the officials and employees of the show blameless for any loss or accident to his horse, employees, equipment, which may occur from sickness, fire or otherwise.

The management reserves the right to refuse, accept conditionally, or to cancel any entries, disqualify any riders or exhibitors, prohibit entries and cancel award prizes without claims for damages; to cancel or combine unfilled classes, or to reschedule classes after due notice to exhibitors; to change rings or rotate judges.

Exhibitors are notified that any act of discourtesy or disobedience to the judges or officials, on the part of the owner, manager, rider, or groom shall disqualify the horse, and the owner shall forfeit his entry fee and other fees.

Show management reserves to itself the power to prohibit any person from attending or showing a horse in the ring and to remove any groom or horse from the show without being liable for compensation.

In accordance with the 1989 Federal Waste Tracking Act, which restricts the disposal of medical waste, bio-hazardous medical waste containers will be provided in the stable area. All exhibitors and their agents are responsible for the proper disposal of this waste.

No person will be allowed in the show ring during the time of judging except the exhibitor and those having official or requested duties to perform.

It is the tradition of the show that riders be correctly attired for the class in question, that attendants be neatly dressed and the horses properly presented. Management may in its discretion bar any person from entering the ring if not suitable presented to appear before an audience.

#### • USEF Sharps Containers Rule (GR1210.4):

Competition management shall place a minimum of one sharps container per each competition, whether or not stabling is provided. Additionally, at least one sharps container per fifty occupied stalls for the disposal of needles and other disposable sharp instruments in convenient locations in barns housing competition horses. It is competition management's responsibility to replace such containers when full and dispose of them properly. Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments. Competition management will place a notice of this requirement either in its prize list or on a specific handout given to trainers on check in at the competition. If local law has different requirements, local law will prevail. Competitions failing to comply with placing the required number of containers on the show grounds will be considered in violation of the rules and may be subject to penalty as determined by the CEO or his designee and/or the Hearing Committee.

## **USEF SAFE SPORT TRAINING REQUIREMENT**

Starting January 1, 2019, if you are a USEF Competing Member 18 years of age or older you are required to complete the core Safe Sport Training within 30 days of activating your membership.

If you do not complete the training, you are ineligible to participate in all USEF activities including competitions.

#### **USEF SAFE SPORT PROGRAM**



- As of January 1, 2019 every USEF adult member (18 years of age or older) with a Competing Membership must complete USEF's Safe Sport Training.
- Required SafeSport Training is available free to all USEF members. Information is at https://www.usef.org/compete/resources-forms/rules-regulations/safe-sport.
- If you are a victim or a survivor of abuse and believe this training could be an emotional trigger, please contact Teresa Roper at <a href="mailto:troper@usef.org">troper@usef.org</a>, Sonja Keating at <a href="mailto:skeating@usef.org">skeating@usef.org</a>, or the U.S. Center for SafeSport at <a href="mailto:training@safesport.org">training@safesport.org</a>, before accessing the Safe Sport Training course.
- A 30 day grace period to complete the SafeSport training will be provided to all members who renew or join on or after December 1, 2018. Members joining prior to December 1, 2018 will have until January 1, 2019 to complete the training. Those who do not complete the training within the grace period will be ineligible to participate in USEF activities, including competitions.
- Parents Training Course for equestrian athletes of all ages helps parents ensure their children have a positive and safe sport experience and is free.
- After the training is completed, it can be verified via <a href="www.eqverification.org">www.eqverification.org</a> within 24-48 hours of completing the training.

#### **USEF SAFE SPORT PROGRAM FAQ**

- Does an entry need to be refused if the owner, trainer and/or rider/handler has not done their SafeSport training?
  No, however if any of the individuals listed above have a current, senior competing membership and are listed as ineligible due to Safe Sport Training, they will need to complete the SafeSport training in order to compete. They may go back to their hotel, residence or other location and complete the training and bring copies of their 'SafeSport Trained' certificate for proof of training to be allowed to compete. If they return with the 'SafeSport Trained' certificate on the first day of competition, their points will count.
- Are non-USEF members required to take Safe Sport training in order to compete?

NO

- Is the "age of 18" requirement calculated by competition year, riding age, or actual age?
   Actual age.
- Do riders who turn 18 during the competition year have to take the SafeSport training?
- If a rider turns 18 during a show, do they need to take the SafeSport training to continue competing? No, they have 30 days to complete the training.
- If the 30 day grace period for someone to take the SafeSport training expires during a competition do we have to ask them to leave?

No, and their points from the current show would still count; however, they will go on the ineligibility list until they successfully complete the training.

- Does a Foreign rider have to take SafeSport Training?
  - Yes if he/she has a USEF Competing membership and is 18-years-old or older.
- If a horse is shown and the owner has taken the SafeSport training, but the senior member trainer or rider has not and is overdue, will that horse's points count?

No.

- If the senior member owner, rider, or trainer was ineligible at the start of the show, but does the training after the show starts, will the horse's points count?
  - If the senior competing member owner, rider, or trainer completes the SafeSport training on the first day of competition, prior to competing and presents the 'SafeSport Trained' certificate to the secretary, then they can compete and their points will count. If the SafeSport training is completed after the first day of competition and the 'SafeSport Trained certificate' is presented to the secretary, they can compete, but their points will not be good.
- If someone is eligible on the start day of the competition but becomes ineligible during the competition, should the competition allow them to continue to compete?
  - Yes, the eligibility for a competition is based on the start date of that competition.
- If the owner of the horse on the entry blank is a farm and the Active Owners of the farm are ineligible due to Safe Sport Training, is the horse allowed to compete?
  - Yes, the farm is not required to take Safe Sport Training and thus the horse is eligible. The Active Owners of the farm are not allowed to compete themselves in the roles of rider, ..., owner (as individual owner of a horse on an entry blank), lessee (as individual lessee of a horse on an entry blank), agent, coach or trainer until they complete Safe Sport Training.
- If a horse is leased and the lease has been recorded with USEF and the lessee is an active member who has completed their Safe Sport Training, will the horse be allowed to compete and will its points count if the actual owner of the horse has not completed their Safe Sport Training?
  - Yes, per USEF rules, the lessee of a horse is considered the owner of the record of the horse during the period of the lease.
- If a trainer is suspended/ineligible for something other than Safe Sport Training, will a horse's points count? No, if a trainer is suspended/ineligible, a horse's points will not count

#### 25. USDF INFORMATION

#### 2020 USDF Recognition Page

<u>USDF Membership Benefits:</u> USDF is dedicated to education, the recognition of achievement, and promotion of dressage. For details on member benefits, including educational programs, awards, and other opportunities, refer to the *USDF Member Guide* or the USDF website at www.usdf.org.

This competition is recognized by USDF for 2020

Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders

and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

#### Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those
  sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at
  Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are
  exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot,
  academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM
  identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

#### Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$90), 5-years (\$360), or life (\$1,800). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$72). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

**Group Membership (GM):** A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards program.

**Business Membership (BM):** A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$240) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$35 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$35). Scores earned by a horse with an HID number will be recorded, but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$80. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$115) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

#### How to Join USDF

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

- On the USDF website: www.usdf.org. You can submit the application online or download the form and fax or mail it to the USDF office.

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.

## USDF Statement on Animal Welfare

The United States Dressage Federation, Inc. (USDF), a federation of over 100 independent organizations throughout the United States with a member-ship of nearly 30,000 members, supports the concept of ethical treatment of animals.

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, comfortable, and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved.

The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed.

Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life.

While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious existence. Under domestication, the horse is assured of ample food, water, and shelter, as well as protection against infectious diseases and damaging parasites, thus leading a longer and healthier life with a high rate of survival.

As an educational organization, USDF has numerous programs, which teach people how to pursue the accepted, humane training methods. A program of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training.

# 2020 Great American Insurance Group/USDF Regional Dressage Championships

A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at <a href="https://www.usdf.org">www.usdf.org</a>. Please refer to the 2020 USDF Member Guide for the comprehensive list of rules and requirements for this program.

#### Membership/Registration Requirements for Qualifying and Championships

All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.

#### Rider:

- Must have a USDF Participating\* Membership (PM).
- Must have a USEF membership (Junior Active, Senior Active, or Life).

#### Horse:

- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s) of record.
   A horse is not required to have breed registry papers.

#### Owner:

- Must have a USDF Participating or Business Membership and a USEF membership (Junior Active, Senior Active, Life, or Recorded Farm (with Active Farm Owner)). If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF. For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF.
- \* PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

**Minimum Qualifying Scores:** One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider. FEI Junior and FEI Young Rider classes have only one respective division. Freestyles have only open divisions.

Adult amateurs wishing to qualify to compete in an Adult Amateur Equitation Regional Final may do so by meeting the following requirements.

#### **Qualifying Requirements**

To be eligible for the USDF Adult Amateur Equitation Regional Final class, rider must have

a) Earned a score of 70% or higher in any dressage seat equitation class (except walk/trot) at a USEF-licensed/USDF-recognized Dressage competition within the qualifying period of the applicable regional championship.

#### or

b) Qualified to compete in any regional dressage championship class (excluding freestyles).


#### **Membership Requirements**

- Rider must have a USDF Participating Membership at the time the qualifying score is earned, and at the time of the Regional Final class.
- Rider must be an adult amateur, in accordance with GR1306 of the USEF rules, and be designated with USEF as an adult amateur when the score is earned, and at the time of the Regional Final class.
- Owner must have a USDF Participating or Business Membership when the qualifying score is earned, and at the time of the Regional Final class.
- Horse must have a USDF Lifetime Horse Registration when the qualifying score is earned, and at the time of the Regional Final class.
